The DTCN can be obtained from Municipality website or from office in person on payment of ₹500.00 (Rupees five hundred) only towards cost of tender/ quotation documents in shape of Cash/ DD/ Bankers Cheque drawn on any Nationalized Bank in favour of the Executive Officer, Paradeep Municipality payable at Paradeep. Quotation without payment of paper cost shall not be accepted in any case and will be rejected summarily. The cost of tender/ quotation paper is not refundable. The terms and conditions as given in the tender/ quotation call notice No. 2222 / dt 21.05.2026 form an integral part of this detail tender call notice.
- 2 The bidder must be accompanied by EMD/ tender security amount of ₹1000.00 (Rupees one thousand) only in shape of Cash/ DD/ Banker cheque drawn on any Nationalized Bank in favour of the Executive Officer, Paradeep Municipality payable at Paradeep.

The authority will not be responsible for any delay towards non receipt of tender/ quoton documents in time. - 5 The tender/ quotation/ bid documents will be **opened on dt. 02.06.2026 at 01:00 PM** in the office chamber of the Executive Officer, Paradeep Municipality in presence of bidders or their authorised representatives if any who wish to attend. If office happens to be closed for any reason on the date for receiving/ opening of the tender as specified, then the tenders will be received/ opened in the next working day at the same time & venue.
- 6 Bidder should submit self attested copies of (i) PAN Card, (ii) MSG Certificate etc. along with the bid document. Quotation without one or more of these documents are bound to be rejected.
- 7 The Quotationer must quote single rate for each item according to the required specification where ever mentioned. More than one rate for a particular item will be summarily rejected. The schedule appended to the quotation call notice should be filled up and signed.
- 8 The bidder shall quote an all inclusive rate includig cost of cloth, stitching charge, tranporting all labour, material etc.
- 9 The rate shall be quoted inclusive of all taxes and duties if any and should be mentioned in both figure and words.
- 10 Any correction or overwriting in the offer should be attested by the quotationer.
- 11 The rate will be valid for one year.
- 12 The quotationer shall submit the quotation schedule duly signed by her with seal failing which the offer will be rejected and will not be considered in comparative statement.
- 13 The materials/ fabrics will be inspected by the Executive Officer/ Sanitation Expert of Paradeep Municipality or any other competent authority.
- 14 Any fabric found defective is to be replaced immediately free of cost.
- 15 The quotationer shall not sublet, transfer or assign any part of the full work of this award without prior written permission from the Executive Officer, Paradeep Municipality.
- 16 The successful bidder will take measurement of Swachha Karmis for uniform & stitching.
- 17 The EMD shall be forfeited on the followig ground  
(i) If successful bidder fails to supply within the period mentioned in the work order.
- 18 Quotation shall not be considered through Power of Attorney.
